I hereby irrevocably submit to the exclusive jurisdiction of the courts and I agree that no other court can exercise jurisdiction over the terms and claims referred to herein. Any litigation to enforce this waiver will be instituted in the Province or Territory of Canada or the State or County in the United States in which the "Equine Activities" are provided by the "Host". I confirm that I have had sufficient time to read and understand this waiver in its entirety. I understand that this agreement represents the entire agreement between the "Host", myself as Parent/Guardian, and the Underage Participant, and it is binding on myself, the Underage Participant and our "Legal Representatives".
